




Sir,

With due respect, I the undersigned have the honour to state few lines about an incident that took place last night at around 11:30 pm of 1st January, 2024 at my residence i.e, Thanga Chingkha Leikai, Leihaothabam Leirak. My mother (Smt. Oinam Pramo Devi aged about 56 yrs) and my father (Shri. Oinam Shyam Singh aged about 58 yrs) had been beaten up brutally by my neighbour Oinam Dijen @ Bijen Singh (55 yrs) along with his son Oinam Bipinchandra @ Bipin (23 yrs) of Thanga Chingkha Leikai by entering inside my house.

My parents had been given first aid, some stitches at left eyebrow of my father, they are still under medication, planning to get to other hospitals for further treatment.

I strongly opposed the brutal action/behaviour of them, even they beat a women at late night.

So, I therefore request you to kindly take some necessary immediate action as per law against them.
