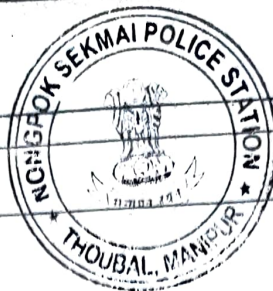

With due regards, I beg to state that today i.e. 03/07/2024 at about 04:00 a.m. received a reliable input from 165 TA and 4 AR that some unknown miscreants have stored and hidden some arms and explosives at the surrounding villages i.e. B. Phainom and Haokhong village area under the jurisdiction of NSK-PS.

On receipt of the information, Special Operation Group (SOG) Thoubal District Police along with a column of 4 AR A-Coy, COB, Thoubal led by Shri Th. Dinesh Singh, DSP(Ops)/TBL and a team of NSK-PS under the command of Shri H. Devendra Singh, MPS, Addl. SP(Ops)/TBL and under the overall Supervision of Shri. Rakesh Balwal, IPS, Sr. Superintendent of Police, Thoubal have rushed to the spot immediately and launched a massive operation at 04:30 a.m. On searching and found one carry bag pink in colour and one article wrapped with car cover silver in colour being store and hidden at the bush beside the water tank of Haokhong near Irong village. On opening the above said articles i.e. carry bag Pink in colour and found i.e. i) 6 (six) nos. of 36 HE Hand Grenade (can be used as explosive), ii) 2 (two) nos. of Detonator and iii) 2 (two) no. of Tear Smoke Shell Soft Nose. In continuation the other article i.e article wrapped with car cover silver in colour was opened and found- 1 (one) no. of Pompei (country made canon). And all the articles were further seized from the spot at 6:45 a.m. The massive searched Operation was conducted from 04:30 am and continued till 07:45 am of the same day.

So it is therefore, handed over the seized articles to you for your kind consideration and further necessary action.
