Sir,

With due regards, I beg to state that today i.e. 10/07/2024 at about 01:05 p.m. received a reliable information that some unknown miscreants have stored and hidden some arms and explosives at the General area i.e. Salam Patong which is under the jurisdiction of NSK-PS.

On receipt of the information, Special Operation Group (SOG) Thoubal District Police along with a column of 4 AR C-Coy, COB, Chandrakhong including 2 teams of CDO Unit, Thoubal i.e. Golf 46 & 52 led by Shri H. Devendra Singh, MPS, Addl. SP(Ops)/TBL and under the overall Supervision of Shri. Rakesh Balwal, IPS, Sr. Superintendent of Police, Thoubal have rushed to the spot immediately and launched a massive operation at 01:50 p.m. On searching and found i.e. i) 2 (two) nos. of 36 HE Hand Grenade without detonators (can be used as explosive), ii) 1 (one) no. of Modified Shell (Pompi Bomb), iii) 1 (one) no. of Cartridge 38 mm marked as rubber bullet and iv) 1 (one) no. of Tear Smoke Shell Soft Nose which were wrapped by a plastic brownish in colour found inside a black carry bag marked as XNL. And the said bag was kept concealed in a pitch covered by wooden floor. And all the articles were further seized from the spot i.e. near Salam Patong Church at 2:46 p.m. The massive searched Operation was conducted from 01:50 pm and continued till 03:45 pm of the same day.

So it is therefore, handed over the seized articles to you for your kind consideration and further necessary action.
