Sir,

I have the honour to submit that on dtd. 21/02/2024 at about 11:48 am my brother namely, Moirangthem Suresh Singh (43) S/o. (L) M. Leikhamtombi Singh of Ngangkhalawai Awang Leikai, P.O & P.S :- Moirang, Dist.:- Bishnupur, Manipur who was driving an Activa 6G blue in colour bearing regn. No. MN 06 SE 3087 proceeding from Moirang Lamkhai side towards Imphal side was hit by a Grand i/10 Hyundai car bearing regn. No. MN 02B-9986 coming from opposite direction which was driven by an individual namely, Md. Abomiya, Hav. No. 9096 S/o. (L) Md. Kamal of Kwakta Khuman, who is presently posted at 2<sup>nd</sup> IRB, Naranseina at Ngangkhalawai Near Power House along Tiddim road NH-2 and due to the rash and negligent driving on the part of the said Grand i/10 Hyundai car driver. As a result of which, my brother received injury on his person and evacuated to hospital for medical treatment. The Hyundai i/10 car bearing regn. No. MN 02 B-9986 was also partly damaged.

In the light of the above facts and circumstances, I would like to request sir to kindly take up necessary action against the said i/10 car driver by registering an FIR under relevant section of the Indian Penal Code.
