Today i.e. 11/06/2024 at around 10.30 pm, a huge villagers from all the villages of Khongjom and its adjoining villages, numbering about 1000 including both male and female gathered together in front of the Gate of Khongjom Police Station and formed an unruly violent mob thereby holding deathly sharp weapons which are axes, spades, daggers, daos, stones, bricks etc. and then they tried to open the PS Gate forcibly using the deathly weapons and also pelted stones and bricks to the police personnel from all the outside four surroundings of the PS campus, with an intention to released two arrested persons of reference case FIR No. 15(06)2024 KJM-PS U/s 17/20 UA(P)A. Act. In that the police personnel of Khongjom PS led by myself along with the 01 (one) team of CDO unit Thoubal i.e. Golf- 65, and 1st Bn. BSF C-coy stationed at Khongjom P.S., put great effort to control and dispersed the violent unruly mob by firing many rounds of Tear Smoke Shells, Smoke Grenades of different munitions etc. in the open air to dispersed the unruly mob, then the unruly mob supporters gradually dispersed. During the incident the unruly violent mob had destroyed 02 (two) nos. of CCTV cameras, 1 (one) no. of Solar Lamp and 1 (one) signboard of PS installed in front of the PS. In the said incident there was no report of any casualty both on the police personnel and civilian side.

Hence, a suo-moto case under FIR No. 16(06)2024 KJM-PS U/s 147/148/149/353/406/427/456/511/34 IPC and 3 PDPP Act. 1984 has been registered for investigation.
