That, I am a bonafide citizen of India having a permanent resident of stated place and as such I am entitle to get all the rights and protections as provided under existing law of the land.

That, I was married to the Accused No. 1 namely Dr. Md. Tajuddin (33 ) yrs. S/O Alhaj Siraj Ahamed on 01.10.2023 in accordance with prevailing/ enforcing Sunni School of Muslim Law in the State of Manipur and also registered our marriage before Marriage Officer, Imphal East Perompat on 4th day of October 2019 by celebrating in other form before our formal marriage.

That, after our marriage I have been living at our matrimonial home situated at Mayang imphal Bengoon. till 15.01.2024 and on the evening of 15.01.2024, the accused no. 1 dropped me at my parental residence and told/ assured me that he will come back again on 16.01.2024 and shall pick up me but he never come.

That, In the morning of 17.01, 2024 it came known to me from someone through mobile phone that the accused no. 1 had eloped with another girl namely Miss. Preeti@ Atika Choudhury D/O Md. Ibomcha @ Nazbul Hussain from Kshetrigao Chandam Leikai and also carne known to me that the said girl also performed Nikah to the accused no. 1 on 16.01,2024.

That, thus I have been living at my parental residence since 15.01.2024 till date without providing any sort of maintenance and also failed performed all the mandatory obligation (s), such acts of the accused no. 1 causes grave injury or danger to life both mentally and physically.

That, all of a sudden on 10<sup>th</sup> June 2024 at about 7.45 P.M, the Esha Namaj timing ( prayer timing of Esha ) while all the male family member my parental residence, i.e my father and my brothers were gone for Esha Namaj at the Jame Masajid, Yairipok Bazar , and by taking advantage of the absent of our male family members. I heard and seen some noise / voices and some persons entered/ trespassing forcibly opening the gate and arrived at the Courtyard and I heard calling of my father and my brothers by the persons.

That, in the mean time my mother and my younger sister also came out from the kitchen and then I and my mother can identified one of the person entering into the said spot/ place and standing at our courtyard and calling my father and my elder brother is the accused no. 1 those person.

That, at the said place and time, the accused no.1 was accompanied with—four unknown persons who were covered their face by masks, then the accused no.1 produced a deadly weapon such as small arms and alming/ targeting to us and spoke many bitter words and also threatened to us and then the accused no. 1 with other his associates unknown persons proceeding toward us thereby pointing his arms to us thereby speaking that my father and my elder brother will be killed at any place and at any time and also the accused no. 1 and his other associates unknown persons intimidate that my father, my elder brother and my self will be no more—and in the meantime my mother shouted ( save—us—save—us—)" EIKHOIBU KANBIYU, EIKHOIBU KANBIYU, MASAK KHANGDABA KHUTLAI PAIBA MEE KHARA CHANGLAKE. MASAK KHANGDABA KHUTLAI PAIBA MEE KHARA CHANGLAKE, then the said accused no. 1 and his other associates unknown persons left the spot.

In the light of the above facts and circumstances, it is, therefore, requested that Your kind self be pleased to look into the matter and take up necessary legal action thereby punishing the accused person (s), in accordance with law.
