

As a result, all of us panic and have left the village for our safety. In the process, the following equipments of my Hatchery Unit were stolen.

1. 2 Solar plate 200w each	Rs. 15,000 x 2 = Rs. 30,000
2. 2 Battery 150v each	Rs. 14,000 x 2 = Rs. 28,000
3. Inverter	Rs. 12,000

Total =	Rs. 70,000/- (Seventy Thousand)

I, therefore request to kindly take necessary legal action against the unknown culprits.
Cause of delay in reporting is due to lack of legal knowledge and displacement.
