

Respected Sir,

With references to the above cited subject, I have the honour to report to you as follows;

I am the chief of Ujungmakhong Village, and a scheduled tribe belonging to the *Gangte Tribe*, which is a recognized tribe under the Constitution of India and a permanent resident of Ujungmakhong Village, Kangvai sub.-div., P.O. & P.S.- Moirang, district- Churachandpur, Manipur.

That, on the 24th of May, 2023 at around 6:30 AM, a mob of armed Meitei/ Meitei with sophisticated weapons, who are suspected to be members of Arambai Tengol, Meitei Leepun, Manipur Police Commando along with the Meitei/ Meitei warmongers in and around the area attacked our village, in the process they have looted, vandalised and arson-attacked the said village/ public properties, that includes;

1) Village Community Hall:

- Hall Building (36 x 40)
- Electronics & Electricals
- Furnitures
- Misc

Total Amount= Rs. 51,00,000/- (Rupees Fifty-One Lakhs) Only.

2) Village Anganwadi Centre:

- Anganwadi Building
- Furnitures, Electronics & Electricals, Furnitures and Misc.

Total Amount= Rs. 9,00,000/- (Rupees Nine Lakhs) Only.

3) Village Authority Hall:

- Electronics & Electricals
- Furnitures
- Misc

Total Amount= Rs. 7,00,000/- (Rupees Seven Lakhs) Only.

That, it may also be report that the said criminal activities have cause grave mental agony and incurred huge lose which is estimated to be about **Rs. 67,00,000 (Rupees Sixty-Seven Lakhs) Only,**
