Sir,

On dated 05/03/2024 at @ 09:30 pm received a report from Mr. Khoirom Sanjoy Singh (34) S/o. Kh. Muhindro Singh of Moirang Mamang Ching Laisoi stating that on 05/03/2024 at @ 02:59 pm his Aunt Mrs. Oinam Ibemhal (73) W/o (L) O. Mangi was found unconscious at newly constructed Khamnu Bazar Shed and they evacuated her to Moirang CHC and brought to Shija Hospital, Imphal. When her aunt got conscious she disclosed that one unknown women gave her one tablet and she got unconscious and lost her Ear Ring and she lost all her money. On the same day at 11:10 am, they came to know that her aunt along with one unknown women drop a Grocery items to one shop owned by Mr. Jiten located at Sendra Road. On checking the CCTV footage they found that her aunt and unknown women went toward Moirang Bazar. The same has been endorsed to me for enquiry.

As per endorsed, I have examined the complainant and visited the P.O and drawn a rough sketch Map with proper index. On dtd. 07/03/2024 at 11:30 am examined the victim Oinam Ibemhal (73) W/o. (L) O. Mangi of Moirang Mamang Ching Laisoi. On enquiry particulars of the unknown women accused is found to be Chabungbam Premrata (38) W/o Ch. Maimu (40) of Moirang Khunou Makha Leikai.

On 08/03/2024, I have went to the residence of Mrs. Chabungbam Premrata (38) W/o Ch. Maimu (40) of Moirang Khunou Makha Leikai to arrest Mrs. Chabungbam Premrata. But the accused person is not found in her resident. So, conducted a House Search in presence of the witnesses by preparing a House Search Memo.

Thus, Mrs. Chabungbam Premrata (38) W/o Ch. Maimu (40) of Moirang Khunou Makha Leikai is suspected to have committed the crime as she is escaping from Police arrest.

Hence, a regular FIR is required for smooth investigation of the case.
