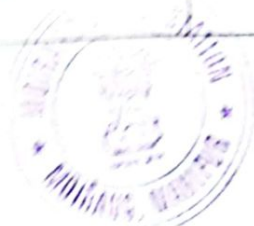

Today i.e dated 15/03/2024 at 9.30 a.m. received a information that on the same day at 9.28 a.m. that some unknown armed miscreants suspected to be cadres of UNLF (P) group coming on two vehicles i.e one Bolero Regd. no not known and one Gypsy vehicle registration no. not known opened fire some 3/4 rounds at Thamnapokpi Makha Leikai near electricity office, Moirang along NH-2 Tiddim road. Further, the said armed unknown miscreants also assaulted two individuals (civilians) coming along the NH.2 Tiddim road along with their private vehicles and sustained injuries on their persons and their vehicles were also damaged by the said unknown arm miscreants .

Hence a regular case under FIR No. 24(3)2024MRG-P.S U/S 400/506/427/326/34 IPC and 25 (1-B) Arms Act is registered on Sou-mottu for further investigation.
