Sir.

I am to report today i.e. 26/03/2024 at around 5.40 pm received a reliable information about the movement of some armed miscreants in and around Moirang area for their prejudicial activities like smuggling and selling of arms and ammunitions, extortion and threatening to general public, businessmen, etc. Based on the information, a combined team of Commando Bishnupur led by Sub. Y. Shaktishen Singh, OC-CDO/BPR assisted by ASI Kh. Prameshwor Singh, Havildar No. 1299017 Samuel Kamei, Havildar No. 411811 Th. Basanta Singh, Hav. No. 1299055 Kh. Kunje Singh, HC N. Manglem Singh under the command of Amarjit Singh Lamabam, MPS, Addl. SP(Ops)/BPR and under the overall guidance of Ksh. Ravikumar Singh, IPS, Superintendent of Police, Bishnupur rushed to the said area and conducted frisking and checking at IV Road of Moirang Thoya to Tronglaobi near Mukta High School.

During the course of frisking and checking, one Maruti Zen white in colour Bearing Registration No. MN1A-7392 was detained with a driver and an occupant who was coming from Tronglaobi side toward Thoya. On spot verification, the driver of the vehicle identified himself as Salam Rameshwor Singh (48) S/O S. Yaima Singh of Chandapur Mamang Leikai and the occupant identified himself as Tongbram Gyanjit Singh @ Chinglensana (39) S/O (L) T. Ibomeha Singh of Chandapur Mamang Leikai, a bailed out cadre of UNLF. On searching of their body and belongings, found a) 20(twenty) live rounds of 7.62 mm ammunition (SLR), b) 01(one) SLR Empty Magazine, c) 01(one) side bag black in colour, d) Rs. 9,000/- (nine thousand) INR in cash, e) 01(one) Xiaomi Smart phone with a SIM card and f) 1(one) Nokia feature phone along with a SIM card was found from Salam Rameshwor Singh and a) 01(one) side bag brown\*in colour, b) 01(one) wallet with Rs. 1980/- INR in cash, c) 02(two) SBI debit card, d) 01(one) Voter card, e) 01(one) Pan card, f) 01(one) Aadhaar card, g) 01(one) E-Shram card, h) 02(two) Smart phone (one Realme & one Redmi) with SIM card each and j) 01(one) Kechaoda feature phone with two SIM cards from Tongbram Gyanjit Singh. On further checking of the vehicle, found one 7.62 mm SLR Rifle Bearing Registration no. 16136787 with one empty magazine at the instance of the driver namely Salam Rameshwor singh. The recovered articles were seized at 6.55 pm and 7.00 pm and the above mention persons were arrested at 7.05 pm, 7.10 pm respectively by observing proper formalities.

In the meantime, one i20 car white in colour coming from Tronglaobi side was seen turning towards Moirang Khunou Hougrampat side in speedy on seeing the police team. On their suspicious nature, immediately, our police team chased the said vehicle and able to detain the vehicle by chasing for some distance at Hougrampat. On spot verification, the driver of the vehicle identified himself as Pukhrem Ingocha Singh (40) S/O (L) P. Ibomcha Singh of Moirang Khunou Hougrampat and the occupant was identified as Thokchom Temba @ Wakheiba (50) S/O (L) Th. Tomba Meitei of Phougakchao-Ikhai Makha Leikai ward no. 3, a bailed out cadre of UNLF. On checking of their body and belongings, a) 01(one) OPPO Smart phone with 02(two) SIM cards and b) 01(one) Baofeng walky talky set was found from Thokchom Temba and 01(one) OPPO Smart phone with 02(two) SIM cards from Pukhrem Ingocha. On checking the i20 car Bearing registration no. MN01AW-8691 found two nos. of 7.62 mm SLR Rifle Bearing Registration No. 16752364 and 16752458 with one empty magazine each from the Dingy of the said vehicle at the instance of the driver namely Pukhrem Ingocha. The above mentioned persons were arrested at 7.25 pm and 7.30 pm and seized the recovered articles at 7.35 pm and 7.40 pm respectively by observing proper formalities.

Hence, the arrested persons along with the seized articles are handed over to you for taking further necessary legal action against them.
