Sir,

I am to report that today i.e. 10/04/2024 at @ 07:55 pm based on received of information for firing of some few rounds at Phubala area near TP School along NH-2, immediately the teams of Bishnupur District Police led by OC-Moirang Police Station, myself along with my team and assisted by Hav. No. 072007046 Mutum Roniboy Singh of 7<sup>th</sup> IRB now attached with CDO-BPR under the command of Y. Shaktishen Singh, OC-CDO/BPR under the suspervision of Satyam Takhellambam, MPS, Addl. SP(L/O), Bishnupur and Amarjit Singh Lamabam, MPS, Addl. SP(Ops), Bishnupur under the overall guidance of SP/Bishnupur rushed to the said area and conducted cordon and search operations at Phubala area.

During the course of operation OC-Moirang PS and two teams of CDO-BPR while conducting frisking and checking at Phubala area to the passerby. In that, the teams gave signal to stop one A-Star Car coming from Ningthoukhong toward Moirang side. Instead, the Car drove away swiftly and tried to escape from the police team. On their suspicious nature, immediately OC-Moirang PS and two teams of CDO-BPR chased the said vehicle and able to detain the vehicle by chasing for same distance at Sunusiphai along Tiddim road NH-2. In the meantime, SDPO, Moirang and DSP CDO II arrived at the spot for re-enforcement. On spot verification, the driver of the vehicle identified himself as 1) Abujam Bishworjit Singh (36) S/o A. Modhu Singh of Thinungei Awang Leikai and the occupant identified himself as 2) Angom Suresh Singh (39) S/0 (L) A. Nabakumar Singh of Thinungei Mayai Leikai. On searching of their body and belongings, 1 (one) Poco C51 smart phone black in colour along with a Sim Card was found from Abujam Bishworjit Singh and 1 (one) Redmi smart phone black in colour along with two Sim Card was found from Angom Suresh Singh. On further verification, Abujam Bishworjit Singh disclosed that he had fired 6 (six) rounds from one .303 Rifle near T.P School Phubala. On further checking of the A-Star Car bearing registration No. MN07L-1336, found one .303 Rifle bearing Registration No. 47626X with 1 (one) magazine having 4 (four) live rounds (one empty case of bullet in the chamber), 1(one) empty case of bullet from the said vehicle at the instance of the driver namely Abujam Bishworjit Singh. Hence, they were arrested at the spot at 08:30 pm and 08:40 pm respectively and also seized the same recovered articles at 08:50 pm and 08:55 pm respectively by observing proper formalities.

Hence, the arrested persons along with seized articles are handed over to you for taking further necessary legal action against them.
