Today i.e. 23/06/2024 at 6:50 pm received an information that on the same day at around 6:45 pm one Honda Activa ridden by unknown rider coming from Yairipok Bazar side towards Yairipok Khoirom side collided with one unknown Auto Rickshaw driven by unknown driver coming from opposite direction at Yairipok Khoirom Makha Leikai near Golden Pillar Foundation School along Yairipok Chandrakhong road due to rash or negligent driving on the part of unknown driver of the Auto rickshaw. Resulting the rider and the 2(two) pillion rider of the Honda Activa sustained injuries on their persons and evacuated to Hospital for medical treatment. The Honda Activa was also partly damaged.

Hence a sou-motto case under FIR No. 30(06)2024 YPK-PS u/s 279/338/427 IPC has been registered for investigation.
