I, Meikam Jaykumar Singh, Inner Agent of Congress Party, would like to register a First Information Report (FIR) regarding an incident of intimidation and disturbance (physically) that occurred at the polling at the Moirang Assembly Constituency (AC). I am representing the Congress Party as an Inner Agent at Polling Station 27/19 Shribon Junior High School, Moirang AC.

On 19-04-2024, at 9:30 am while performing my duties as an Inner Agent at the aforementioned polling station, the unknown miscreants visited the polling station threatening me. The miscreants force me to vacate the polling station and ceased my activities on behalf of the Congress Party. They also threatened me with dire consequences.

Kindly therefore register this FIR and initiate a thorough investigation into the matter. I am willing to provide any further information or assistance necessary for the investigation.
