Sub: Report.

Sir,

I have the honour to state that on 22/06/2024 at about 5.30 am received a reliable information that some unknown armed miscreants have stored and hidden some arms, ammunition and explosive at the Waithou foot hill area, opposite stone crusher.

On received of the information, special operation group (SOG) Thoubal Districts Police along with COB Lilong 33 Assam Rifle and led by Inspt. K. Nitarajan Singh, OC/CDO-TBL under the supervision of Shri H. Devendra Singh, Addl. SP(Ops) TBL and under the overall supervision of Shri Rakesh Balwal, IPS Sr. SP Thoubal have rushed to the spot immediately and launched a massive search operation at 06:30 am by using metal detectors. On searching, the undernoted arms and explosive items were found i.e.

- 5) 02 (two) nos. of Chinese Hand Grenade,
- 6) 01(one) no. of Revolver 6 round, (marked as made in USA)
- 7) 02 (two) nos. of 2 inch mortar Cell,
- 8) 02 (two) nos. of 81 mortar Cell,
- 9) 01 (one) no. of Wireless Set. (Labeled as DIGITAL MBILE RADIO)
- 10) 01(one) no. of IED,
- 11) 02(two) nos. of Smoke Cell,
- 12) 02 (two) nos. of Smoke Grenade,
- 13) 01 (one) no. of SLR magazine

14) 01(one) no. of assault Rifle magazine, respectively from the spot and the same have been seized at 7.20 am by observing formalities. The massive search operation was conducted on the same day from 06:30 am to 08:30 am.

It is therefore, handed over the seized incriminating articles to you for further necessary legal action.
