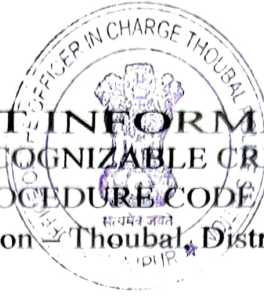

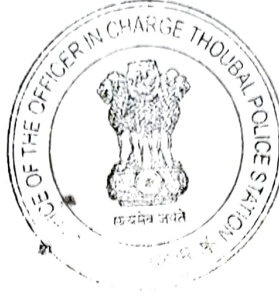

Sir

In continuation of the Letter No. EE/TBL-PHE/F-11/24-25/79, dated 24th May 2024 of my office to you regarding the incident happened in the midnight of 17th May 2024 and 18th May 2024 under your jurisdiction, I have the honour to state the following for your kind investigation:

1. You have visited the site of the incident personally on 18th May 2024 at morning. Also, on 24th May 2024, I submitted a list of documents of (a) completely damaged, (b) partly damaged, and (c) intact in the said fire ablaze to you;
2. Although the incident was later managed to be controlled by the Thoubal Fire Service, the cause of the fire blaze remains unknown. It was earlier believed to have started due to a short circuit. However, the incident seems to be occurred by such mischief of fire with an intent to destroy our office by some unknown miscreants;

It is; therefore, you are requested to register this case an FIR, and to investigate the matter as soon as possible and take necessary actions.
