

Today i.e. 02/06/2024 at 1:00 pm, received information that on the same day at around 12:50 pm, one Tata Truck B/Regn. No. MN06T0443 driven by unknown driver proceeding from Thoubal Bazar towards Leishangthem side along Mayang Imphal (MI) Road collided with one Scorpio B/Regn. No. MN01AK3111 driven by unknown driver which was proceeding from opposite direction i.e. Khekman to Thoubal Bazar at Khekman Huirongbam Leikai due to rash or negligent driving on the part of both unknown drivers. As a result of which, the unknown driver and 3 (three) unknown occupants of the Scorpio B/Regn. No. MN01AK3111 received serious injuries on their persons and evacuated to Hospital for medical treatment. The said Scorpio was badly damaged, whereas the Tata Truck was partly damaged.

Hence, a suo-moto case under FIR No. 58(6)2024 TBL-PS U/S 279/338/427 IPC has been registered for investigation.
