Subject: Report.

Sir,

It is to report that yesterday i.e., 18th January, 2024, at around 10.10pm a large no of unknown armed miscreants suspected to be Arambai Tengol who came by 35/40 light vehicles and on foot numbering more than 700 stormed the main gate of Bn Hq. at Naranseina and tried to loot/snatch the arms and ammunition of 2nd IRB Bn.Hq. kept under lock and key at the armed Kote inside the Bn campus where a platoon of Hq. platoon, D-Coy. 198 Bn CRPF along with personnel of 2nd IRB were on guard 24/7 daily.

The unknown armed miscreants suspected to be Arambai Tengol entered inside the campus by breaking the main gate and started firing in the dark and ran towards the armed Kote. Personnel of 2nd IRB and Hq. platoon of D-Coy. 198 Bn. CRPF also retaliated by firing. The exchange of fire started from 10.40 pm and continued till 11.45 pm. Due to the stiff resistance of both CRPF and 2nd IRB personnel, the armed Kote could not be breached and the unknown armed miscreants suspected to be Arambai Tengol started to retreat in the dark. However, our unit bullet proof vehicle 407 bearing registration no. MN-01/5100 (olive green in colour) driven by C/D. No. 10D0499 N. Biran Singh which was parked at the gate was overpowered by the unknown armed miscreants suspected to be Arambai Tengol and forcibly taken away. In the scuffle, one 9mm. Pistol bearing regd. No. 16210296 along with 2 magazines & 20 live rounds issued to C/Drv. No. 10D0032, N. Jiten Singh was also snatched along with one INSAS Rifle bearing Regd. No 18483654 along with 3 Magazines & 60 live rounds issued to Rfn. No. 1299288 Th. Dhiren Singh.

The unknown armed miscreants suspected to be Arambai Tengol also broke the store room located at the south eastern corner of the campus where Bn. equipment were kept and looted 17 nos. of old heavy weight BP jackets along with 22 old patkas and 4 nos. of BP light weight jacket with 4 Kevlar. At around 12.10 am the situation have been brought under control. No causality and injuries occurred on the part of CRPF and 2nd IRB personnel.

During the exchange of fire, 24 rds. of 7.62mm BDR ammunition were fired.
