Sir,

I have the honour to report that on 14/6/2024 at around 08.30 am, while my father namely Sanasam Kaoba Singh 65yrs S/o. (L) S. Khomdon Singh of Tentha Mayai Leikai Pukhri Achouba Mapan was trying to cross the road of the NH-102 near MS Sorojini Oil Pump to the direction of Wangjing side by riding his two wheeler vehicle Honda Dio bearing regd. No.MN01AD-9174, suddenly dashed on his vehicle by one four wheeler vehicle Bolero bearing regd. No.MN06LX-0577 driven by unknown driver which was coming from Wangjing towards Thoubal side. As a result of which my father sustained injury on his persons and evacuated to District Hospital for medical treatment. Now, he is further undergoing treatment at Advance Hospital, Imphal.

It is therefore, requested to take up necessary legal action in this regards.
