Subject: Report



Sir,

I have the honour to report that on 04/04/2024 at about 05:30 AM, based on a specific input from own sources and corroborated by 5 Sikh Regiment about the movement of miscreants and caching explosives, arms and ammunitions in the general area foothills in the southern side of Sadu Nepali Basti between Laimanai road and Khoijairok nalla under Loktak-PS, a combine team of Bishnupur District Police CDOs Led by Sub. Y. Shaktishen Singh OC/CDO-BPR assisted by SI P. Sunil Singh and Th. Basanta Singh (Hav. No. 411811), a team of Loktak-PS led by Inspt. Md. Abdul Gaffur Masood OC/LTK-PS under the command of Shri Amarjit Singh Lamabam, MPS, ASP (Ops-BPR), a column of 5 Sikh Regiment Led by Maj. KS. Bhati and Lt. Sunil and two section of C-29 SSB led by AC Ravi Kumar under the supervision of Shri Ksh. Ravikumar Singh, IPS, SP-BPR conducted cordon and search operation in the said area. Some suspected area were cordoned from 0600 hrs and search started. In the operation the following arms and explosives were recovered from the foothill southern side of Sadu Nepali Basti at around 9:00 AM. Further the operation was closed at 9:30 AM.

Particular of the seized items are:-

1. One SMG Carbine bearing no. EED-23702.
2. One MK-II Sten Gun bearing no 501/247 with one Magazine.
3. One Anti-Riot Gun bearing No 187102680.
4. One 303 Rifle (local made).
5. One 9 MM pistol (local made) with one magazine.
6. Six nos. of Tear Smoke Shell.
7. Three nos. of tube launching-1A.
8. Thirteen nos. of 36 hand grenade.
9. One no. of Chinese hand grenade.
10. Eleven nos. of 5.56 live rounds.
11. Three nos. of 7.62 cartage. Live round.
12. Five nos. of grenade launching ring.
13. One no. of BP jacket.

Now, therefore the seized items along with the seizure memo are handed over to you for taking further necessary action.


