

Today i.e. 24/06/2024 at 12:40 pm, received an information that on the same day at around 12:35 pm, one Mahindra XUV 300 B/Regn. No. MN01AS2195 driven by an unknown driver proceeding from Wangjing side towards Imphal side dashed on the back side of Hyundai i10 car B/Regn. No. AS01AZ9828 driven by an unknown driver coming from same direction due to rash or negligent driving on the part of the Mahindra XUV 300 along NH 102 at Thoubal Athokpam Khunou near Arong bridge. Due to forceful impact, the said i10 car crossed the road median and further dashed to another Nissan Terano B/Regn. No. WB06L6606 driven by an unknown driver which was coming from Imphal side towards Wangjing side. As a result on which unknown driver of the i10 car, the unknown driver of the Mahindra XUV and an occupant of the Nissan Terano car sustained injuries and evacuated to Hospital for giving medical treatment. Hence, a Suo Moto case under FIR NO 64(6)2024 of TBL PS, U/S 279/338/427 IPC has been registered and investigated into.
