I, the undersigned have the honour to report that on 27/06/2024 at around 3.40 pm, my son namely Rk. Bilangidesh Singh aged 22yrs along with one person namely Tekcham Abhinash Singh aged about 34yrs S/o. T. Ibomcha Singh of Khongjom Sabal Leikai went out from my house by driving my vehicle A-Star bearing regd. No. WB74P-7507 to take a sum of Rs.200000/- from the elder sister of Abhinash residing at Thoubal Haakha Kiyam. After some while, at around 4.25 pm, my son contacted me from his mobile phone No. 6009590940 and informed me that he was abducted by unknown persons and beaten him without any valid reason from Thoubal Kiyam Wangmataba. Then, the phone call was cut suddenly and got switch off. In the meantime, I tried to contact Abhinash in his mobile phone No.8731009775 but his mobile phone also got switch off and whereabouts of my son is not known.

It is therefore, requested to kindly help to find out my son and take all necessary legal action.
