

IN THE MATTER OF: -

An application under section 156 (3) of the Criminal Procedure Code 1973 praying for taking cognizance of the case against the above-name accused for the offences punishable under section 120-B/378/403/420 IPC.

Date, Time and Place of Occurrence: -

On **08/01/2024** at about 10:30 am at the residence of the complainant, and subsequent dates and times within the jurisdiction of Thoubal Police Station.

Most Respectfully Sheweth:

- That, the complainant is a bonafide law-abiding citizen of India, having residence at the address as mentioned above and currently serving the nation as a Captain in the Indian Army, posting at CME, Dapodi, Pune, Maharastra.
- 2. That, the complainant is well acquainted with the accused who promised to deliver him a Hyundai Creta, bearing Regd. No. WB02AH 4792. The complainant has paid Rs.7,00,000/-(Rupees Seven Lakhs) only in total for the conveyance of the said car. Out of the total amount, the complainant had paid Rs.50,000/- only as an advance to the accused at the residence of the complainant on 08/01/2024 at about 10:30 am.

3. That, thereafter the accused person informed the complainant about the status of the car and asked the complainant to make the payment of the due/payable outstanding amount of Rs.6,50,000/- (Rupees Six Lakhs and Fifty Thousand) only for the same. The complainant, as requested by the accused and desiring to own a car in today's day made the payments of the said amount on different dates through UPI transactions.

- 4. That, after receiving the amount of Rs.7,00,000/- (Rupees Seven Lakhs) only in total for the conveyance of the car in question, the complainant got a "No Objection Certificate" issued by the State Transport Department, PVD KOLKATA, Government of Manipur, dated 22/03/2024. The vehicle was sold to the complainant. (Copy Enclosed)
- 5. That, although the vehicle was sold to the complainant, it has not been delivered to the complainant. Instead, with no consent of the complainant the accused sold the car to someone else, as if the accused was the owner of the vehicle. The complainant had no idea of the same as well. It is pertinent to mention here that the accused was just a broker, and he was supposed to deliver the vehicle to the complainant and the complainant only.
- 6. That, the accused has closed all means of communication with the complainant. The accused even blacklisted the contact number of the complainant. The complainant visited the residence of the accused multiple times but could not find him. His family members also on one pretext or another always made excuses and did not disclose his whereabouts.
- 7. That, the mischievous conduct of the accused, which is theft, made the complainant suffer an irreparable loss and he was disturbed in his day-to-day life and the peaceful life he had before he was encountered with the accused. However, the complainant was able to find



the vehicle in question located somewhere in Wangoi, Imphal West District, Manipur. As a result, the complainant inquired about the case in the Wangoi Police Station, however, for want of an FIR, the Wangoi Police Station did not entertain the case.

- 8. That, the cause of action of this complaint case arose on 08/01/2024 at about 10:30 am and its subsequent dates and there are so many substantial materials/documents which can be proved as a prima facie case and the same is continuing within the jurisdiction of this Hon'ble Court.
- 9. That, the complainant, following the suggestion from the Wangoi Police Station, made a report to the Thoubal Police Station for it being the proper jurisdiction and requested to register an FIR about the case on 11/06/2024 and was received by the ASI M. Sangeet Singh on the same day (G.D. No. 13/TBL-PS/2024 - Copy Enclosed). But the effort went in vain, as the Thoubal Police Station too did not take any action regarding the case.
- 10. That, the complainant on 20/06/2024 made another report about the same case to the Respected Superintendent of Police, Thoubal for taking necessary actions against the This report is treated as
