Sir,
Most respectfully, I, on behalf of The Thangjing Seva Mandal, Moirang beg to state that Kuki-Zo organisations namely, ITLF and ZRA, Chuachandpur had installed a 'big cross' atop Ibudhou Thangjing Khubaulen, popularly known as Thangjing Hill and broken down the sacred cave of Ibudhou Thangjing at the hill whose devotees from across the state and Moirang, in particular used to climb the range to offer prayer in the month of Sajibu over hundreds of years. The said organisations had done this heinous vice/crime twice in the September, 2023 and again recently on 25th January, 2024 grievously injuring the sentiment of the worshippers. Worse still is that the said two organisations had rechristened Thangjing hill as "MOUNT OLIVE" replacing the ages old name. The same was made viral in video clipping appalling every viewer by T.C NETWORK, Chuachandpur.

I am, therefore to lodge FIR against the Presidents of the two organisations namely ITLF and ZRA, Chuachandpur, so that justice is booked against them at the earliest.
