

**Subject: Complaint against Pandam Nidhi Ltd. for Alleged Ponzi
scheme and Fraudulent Investment Practices**

Respected Sir,

We, the undersigned representatives of the Pandam Nidhi Investors Association, Senapati, representing over 184 individuals from Senapati, Manipur, are filing this complaint against the following persons associated with M/s Pandam Nidhi Ltd.:

Facts of the Case:

Pandam Nidhi Limited Senapati branch was established in the year 2021 and operated till September 2022. The office was located near Public toilet Senapati, opposite to Senapati police station. Pandam Nidhi Ltd. operated an office branch in Senapati, offering seemingly lucrative investment plans to attract individuals. We, the investors, were deceived by their false promises and fraudulent agreements, leading us to deposit a substantial amount of money exceeding Rs. 2,85,00,000 (Two Crore Eighty-Five Lakhs only). This figure is likely to be higher upon collecting information from all investors, potentially reaching over Rs. 3,85,00,000 (Three Crore Eighty-Five Lakhs).

Our Grievance:

We believe Pandam Nidhi Ltd. has been operating a Ponzi scheme. Their actions constitute a breach of contract and fraudulent practices aimed at siphoning off our invested money. We cite the Supreme Court decision in 'Lalita Kumari Vs Govt. of UP (WP (cr) No. 68/2008)' which emphasizes the mandatory registration of FIRs for cognizable offenses.

Ukhrul Police Action:

Similar concerns were raised in Ukhrul, leading to the Ukhrul Police taking action by sealing the Pandam Nidhi Ltd. office. This action and news reports published in "The Sangai Express" dated April 2, 2023, further support our claims of the company's fraudulent intentions.

Offenses Committed:

Based on the aforementioned facts, we believe the actions of Pandam Nidhi Ltd. and the individuals mentioned above constitute criminal offenses under the Indian Penal Code (IPC) sections 406 (criminal breach of trust), 409 (criminal breach of trust by public servant etc.), 418 (cheating with knowledge of deception), 420 (cheating and dishonestly inducing delivery of

property), 421 (dishonest receipt of stolen property), 422 (dishonestly deceiving creditor), 477 (forgery of valuable security, will, etc.).

Request for FIR Registration:

We request the registration of an FIR against the aforementioned individuals under the relevant sections of the IPC to bring them to justice and recover our invested funds.
