

Thangjam Ibemhal Devi (56) D/o (L) Thangjam Tomba Singh of Mayang Imphal Konchak Mayai Leikai and placed a hand-grenade bomb inside the house. The unknown persons left the area by driving a vehicle Santro Zing bearing registration not known silky silver in colour towards Sekmaiin side.

Hence, for proper investigation a Suo-Motto case under FIR No. 22(6)2024 MIPS U/s 447/506/34 IPC, 4 & 5 of Expl. Subs. Act has been registered for investigation.
