Sir,

I have the honour to report that on 7/6/2024 at 4 pm one Dr. Md Tajuddin (31) yrs S/o Md Siraj Ahmed of Mayang Imphal Bengoon Salamat Bazar reported that, on 7/6/2024 at about 7 am, he was coming out of his house for his personal matter. On the same day at about 11 am, while he was visiting and staying at Imphal Hospital, some duty staff known to him of the hospital informed him that he was asked by some unknown persons suspected to be with armed are tracing here and there inside the Hospital. With the assistance of police, he returned at his house safely. It is suspected that the unknown persons were hired by Bilkish Banu Ali aged about 34 yrs D/o Md Keramat Ali of Yairipok Bamon Leikai who was my 1st wife and already self divorced by her in collusion with her father, elder brother namely Md Makbul and her uncle namely Korimayum Haji Dawood S/o (L) Md Turab Ali of Yairipok Leikon. In the recent past, several unknown calls from different mobile nos. posing as UGs/anti-social elements have also received by him directing him to arrive at some places instructed by them. They also asked about the relation of his 1st wife. Moreover, they also threatened him by stating that his day to day movements were monitor by them and will be kidnapped/harmed whenever chances come. Due to their activities, it disturbed his normal life feeling what will happen to them in the near future. His family members also got panic. So, an enquiry has been initiated on the above reference GD Entry No.

During the course of enquiry, examined the complainant Dr. Md Tajuddin and he revealed that he received several threat calls from unknown persons phone numbers i.e 1) 9862389957, 2) 6909604402, 3) 7628937118 4) 9485211906 and 5) 9233001892 since last week of April, 2024 to his mobile no 6909258108 while staying at his house as well as at duty place who identified themselves as the members of UG outfits. He was further threatened by telling that the family members of his ex-wife namely Bilkish Banu Ali engaged them for settling about his matrimonial relationship with his ex-wife. Further, the unknown persons repeatedly threatened him to come at Koutruk, Kadangband and Wangoo areas failing which he would be kidnapped by the suspected UG groups. Moreover, it is also true that some unknown persons attempted to kidnap the complainant while he was visiting at Imphal Hospital. In the meantime, the family members of Bilkish Banu Ali are still reluctant to appear at the PS inspite of sending summons through OC/Yairipok PS.

The present enquiry reveals that the complainant who is a medical doctor received many threat calls from different persons suspected to be engaged by the family members of his ex-wife and also he recently escaped from a kidnapped attempt suspected to be committed by the above mentioned engaged persons.

You are, therefore, requested to register a regular case for smooth investigation.
