Today i.e. 19/06/2024 at 4:00 am received a reliable information about the presence of some armed miscreants in the general area of Yangoi for committing pre-judicial activities. Acting on the information, a combined team of District Police, Imphal West led by SDPO-MI under the overall Supervision of SP, Imphal West District consisting 2 teams of MIPS including Women Police led by myself, 3 teams of CDO-IW(Bullet-7, Papa-47 and Papa 60) and teams of 33 AR COB Nambol Maibam Post led by the Post commander Maj. Sahil Rishi conducted Cordon And Search Operation (CASO) at IVR Yangoi and nearby farmhouses from 4.30 am to 6.55 am. During the search operation, the following items i.e. 1). 2 (Two) nos. of SBBL guns, 2). 1 (one) Carbine bearing number RECN-18249837 with one Magazine, 3). 12 (twelve) Numbers of 36 Hand grenade, 4). 7 (seven) numbers of Detonators, 5). 6 (six) numbers of Tube launching, 6). 10 (ten) rounds of CMG ammunitions, 7). 2 (two) numbers of No. 80 smoke hand Grenade and 8). 1 (one) wireless Motorola set with 1 (one) charger which were found putting inside two sack bags suspected to be abandoned by the unknown armed miscreants/gang were recovered from the backyard of an abandoned farmhouse at Yangoi near the farm of Okram Megha Singh. The said items which were likely to be used for extortion/kidnapping were seized at 6:05 by observing formalities.

Hence, It is, therefore, considered to register a case under FIR No 26(6)2024 MIPS U/s 400 IPC, 25(1-C) A. Act, 6(1-A) IWT Act & 5 Explosive Substance Act for proper investigation against the unknown armed miscreants.
