

Today i.e. 16<sup>th</sup> June, 2024 at @ 03.30 PM, found a warning note against the Manipuri Film Actress Maxina Paonam and her mother N. Surnolata on a letter head of KCP (PWG), MC Unification dated 16<sup>th</sup> June, 2024 signed by Thoujal Wangamba, Media Co-ordinator of KCP (PWG), MC Unification in social media. The warning note is reproduced as follows, "Maxina Paonam, apokpi mama gi maming N. Surnolata Devi, leipham Nagamapal Lai Eshing Chaiba na lup asida masana yajana May gi tarik 28<sup>th</sup> 2024 da lanle haiduna masana khutyek pijaduna sengdok chakhi. Adubu mahak lup asibu thaoi-usittaba gum lup ki warep pu natheiraga thanamaga June gi tang 13<sup>th</sup> 2024 da apokpi mama ga loinana Bangkok (Thailand) da Indigo gi flight No. 6E-1057 tongduna chatkhibana maram oiduna lup asigi military council (MC) na Maxina Paonam amadi apokpi mama N. Surnolata Devi bu numit humni (3 days) gi manungda lup asida changjaraknaba haijari. Karigumba lup na piriba matam sigi manungda changjaraktaba taragadi lup asigi military council (MC) na Maxina Paonam amasung apokpi mama anigi mathakta khut tharagani haibagi warep loujare".


The warning note of KCP (PWG), MC Unification translates as follows, "Maxina Paonam D/O N. Surnolata Devi of Nagamapal Lai Eshing Chaibi signed an apology letter to the organisation on 28<sup>th</sup> May, 2024 for her wrong deeds. However, she along with her mother went to Bangkok (Thailand) on 13<sup>th</sup> June, 2024 in Indigo Flight No. 6E-1057 by violating the terms and conditions of the organisation. So, Military Council (MC) of the organisation notify/warn Maxina Paonam and her mother to come to the organisation within 3(three) days failing which stern action will be taken up against her and her mother".

The warning note of the banned outfit KCP (PWG), MC Unification directly threatened the life of any public, or to cause fear and alarm or warning to kill any public by taking laws in their hand.

Hence, a suo-mottu case under FIR No. 340(06)2024 IPS U/s 307/500/506 IPC & 16/20 UA(P)Act has been registered for investigation.
