

I have the honour to report that today i.e. 20th June, 2024 at around 11.00 am, one Hand Grenade along with a demand/warning letter wrapped by a red cotton bag was found kept at the entrance gate of my rented tuition centre "Sir Jotin's Neet Chemistry" which is located at Keishampat Laishom Leirak Machin along Tiddim Road. The bomb might have been kept by some unknown miscreant(s) suspected to be members of valley-based organisation so called KCP- Burma Base with intent to endanger human life or properties.

It is therefore, requested kindly to take up necessary legal action against the culprit(s) as per law of the land.
