

**Subject:** Monetary Demand and Life-Threatening Incident Report

Respected Sir,

I, Jairaj Pukhrambam, am writing to bring to your attention an incident involving the underground organization known as PREPAK. On **March 17, 2024**, they sent a monetary demand letter of **Rs. 3.00 lakhs** addressed to my wife, Sorokhaibam Robita.

Subsequently, we engaged in a discussion with Mr. Mangal R.O. (whose contact number is **7627901476**), representing the organization. During our meeting on **June 14, 2024**, we expressed our willingness to donate **Rs. 10,000/- (Rs. Ten thousand)**, which was within our capacity. However, Mr. Mangal insisted on a higher amount, suggesting that at least **60%** of their demand must be paid.

Today, around **1:00 PM**, we received another call from Mr. Mangal, reiterating their demands. We informed him that we cannot pay the requested amount and reiterated our offer of **Rs. 10,000/- (Rs. Ten thousand)**. In response, he threatened dire consequences and abruptly ended the conversation.

Given these circumstances, I urgently request your intervention. Such incidents can affect anyone, and we hope you will take this matter seriously.
