Today i.e. 21st June, 2024 at 12:20 PM found one statement viral in social media posted by one Face book page "Manipur Updates". The statement is reproduced as follows, "1st MR da Indian Army Thamsinkhrey, Bunker Saba Houre, Main Gate No. 1 da Manipur gi me kana amata chathandare".


The viral statement translates as follows, "Indian Army has been accommodated at 1st MR, also started constructing bunker, and no one is allowed to go through the main gate No. 1".

The fake viral statement or rumour creates panic and unrest to the general public in the presence situation of Manipur. Peoples started enquiring on the matter to the police. Posting such misleading statement in the social media in this critical juncture promotes enmity, hatred or ill-will between different race, castes, clans and communities. Moreover, transmitting such fake news provokes the general public and is likely to disturb the maintenance of harmony, public order and public tranquillity in the state.

Hence, a suo-mottu case under FIR No. 353(06)2024 IPS U/s 153-A/505(1)(b)/505(2) IPC has been registered for investigation against the unknown admin of Face book Page "Manipur Updates".
