I, Kshetrimayum Kelvin Singh, working as Assistant Superintendent of Post Offices, 1st Sub Division, Manipur Postal Division, have been directed by the Director Postal Services, Manipur Division, Imphal – 795001 vide office letter no. F/Irregularity/TRCA/2022 dated 19.06.2024(copy enclosed) to lodge FIR against Md. Abdul Qudus , Postal Assistant Imphal Head Post Office, aged about 51 Years s/o (L) Md. Samsuruddin , a resident of Keikhu Makha Leikai, Imphal, Manipur-795008 in connection with irregular drawal of TRCA(Time related continuity allowance) of GDS officials.

2. I would like to lodge an FIR against Md. Abdul Qudus , Postal Assistant Imphal Head Post Office, aged about 51 Years s/o (L) Md. Samsuruddin , a resident of Keikhu Makha Leikai, Imphal, Manipur-795008 in connection with the irregular drawal of TRCA of GDS officials in Manipur Postal Division.

3. Md. Abdul Qudus , Postal Assistant Imphal HO (now under suspension) who was then dealing with GDS pay(TRCA) , intentionally deposited the pay/TRCA of some GDS staffs to his POSB account no. 1762505819 fraudulently. The amount were then transferred to his IPPB account no. 035410023935. The fraudulently deposited and withdrawn amount detected till date is Rs 86569/- which may increase in future too.

4. You are, therefore, requested to register an FIR against Md. Abdul Qudus , Postal Assistant Imphal Head Post Office, aged about 51 Years s/o (L) Md. Samsuruddin , a resident of

Keikhu Makha Leikai, Imphal, Manipur-795008, and take up further investigation into the matter.
