

Sir,



With due respect, I have the honor to state the following few lines for your kind perusal and further necessary action to take up a regular FIR and to book the culprits according to the law of the land.

That, on 7th June, 2024 at @ 08.00 AM while my whole family was at Delhi for medical treatment of my old aged father, three unknown armed gunman entered inside our residence at Hodam Leirak, Imphal and the unknown armed miscreants identified themselves as active members of NRFM (National Revolutionary Front of Manipur) and they are directed by one Oinam (O) Phurailatpam (N) Victoria (44 yrs) W/O (L) O. Meghachandra Singh of Pishumthong Oinam Leikai, P.O & P.S - Singjamei, Imphal West to settle a loan amount took from Victoria by my wife. They threatened my neighbors' that if we don't pay the loan amount immediately on or before 20th June, 2024 we will face dire consequences. The members of the said organization repeatedly called us from one phone No. +959986640021 and sending many life threatening message and they warn us to settle the matter at the earliest, and to come at a place as and when they desired.

That, due to above mentioned chain of events and repeated life threatening phone calls and messages, my whole family is mentally and physically disturbed thereby causing fear psychosis to the small children of our family and old aged parents.

It, is therefore, requested your good self to kindly take up a regular FIR and book the culprits according to the law of the land at the earliest.
