Today i.e. 26th June, 2024 at @ 04.00 PM, found a viral video in social media of a public meeting speech by Thounaojam Brinda. The public speech of Thounaojam Brinda is reproduced as follows, "Bharat Sarkarna touningba touba matamda Manipur mangnaba touba matamda, Manipur sarkarna yenglaga leiyeba, kei haiba tage emasing keim haiba tade, ma yenglaga leirabanina yabaneba. Adu oiba taragadi eikhoina tougadabashi karino? Chingna laobana taba Meiteina laobana tadreba, adu oiba taragadi houjik leiriba khongfamse, Bharatna Manipur thugaiba ama eikhoina Bharat thugaiba ama, anishigi marakta ngamthok nadragadi yararoi, aduna lakchaninglishi eina ngasai hangbirakpa wahang amada yam fajaba wahangni mashigi wahangse, Manipur pumba Meitei marakta yam chaoba eshase yam kiba faohanba, sondahanba tonga ama khak sandoke. Mashigi tonga shi karino haibada eikhoida PR laktaragadi Indian Army na eikhoise loina hatkhrani, eikhoise loi rape tougrani, eikhoi kamai tougadagena hainabra emasing, haineiko? Aduda eina lakchaninglise eru lujaba taragadi chottaba yaroi, laan touba taragadi shidaba yaroi, adu oitaragadi lanse makha chattharaga lanse ngamthok nase haitaragadi, eikhoi shinaba sem sada yaroi ahanbada. Thengnagadoise kuki natte, Bharat ki lanmi singne eikhoina thengnadoise, kuki di sumaina loisingadaba natte, kuki loishangadaba, tonganna eikhoi khatangna loisingadabani, moina kuki ngaklaga thamhanba yade. Aduna eikhoina thengna gadoise Bharatki lanmi sing thengnagadoini Manipur police eikhoida onsinlak kani Bharat ki lanmi eikhoida onsinlak kani. Meitei na puwarida lishang shitna eikhoi akiba haibase eikhoida amata leirakte eikhoi yeknaba khwaidagi shakti leiba khulai paiba yeknaba khuding thengainaraga, muktheknaraga, ngamtheknaraga lakpa phurup ni. Mashigi shakhidi karino haibada Bharat hairiba leibaksigi manungda leiba lam amtada including Jammu & Kashmir yaona Meiteina Bharat leingak singnaraga lakesey sumaina kanamtana singnaba ngamde ngac faoda.

The public speech of Thounaojam Brinda is translated as follows, "When Government of India is doing freely and anything against the state of Manipur, the Government of Manipur is a mere spectator. What are we supposed to do, the government listens only for the hill people and not for us. The last resort is either the Government of India break the state or we break India. Now a rumor has been spreaded all over Manipur to frighten everyone that if PR comes in Manipur then the Indian army will killed all of us and rape all of us. Now, my point is that if we take bath we will have to get wet and if we start waging war, dead is certain. If we are ready for the war we have to be ready to die. Our real enemy is Indian army not Kuki. The Indian armies are protecting the Kuki, there is other way to finish the Kuki. Since the Indian armies are protecting the Kuki we have to fight the Indian Army. The Manipur Police and Indian army will start fight against us. We have a long history that Meitei knows no



fear and we defeat the entire enemy though they have powers. We have proof that nowhere in India including the State of Jammu and Kashmir, no one is opposing and revolting against the Government of India like Meltel.

The public speech of Thounaojam Brinda is to cause fear and alarm to the general public, or to any section of public. Her intention is to induce different communities to commit any offence against the public tranquility and incites any class or community to promote enmity, hatred or ill-will between classes on the ground of religion caste or community. Her statement also incites the general public to fight against the Union of India. Moreover, transmitting such videos of public speech against the state force and central armed forces at this juncture of crisis in Manipur may provokes the general public and is likely to disturb the maintenance of harmony, public order and public tranquility in the state.

Hence, a suo-mottu case under FIR No. 361(06)2024 IPS U/s 121-A/153-B/505(2)/506 IPC has been registered for investigation.
