I have the honour to state that today, i.e., 26/06/2024 at about 12.30 p.m., on request by a team of Thoubal District Police to assist them in causing arrest of one accused person, namely, Moirangthem Totomshana @ Nongshaba of Heirok Part 2 Mayai Leikai Pujari Chithek, in C/W FIR No. 04 (04) 2024 HRK PS u/s 147/148/149/34/341/186/427 IPC, from the place near Imphal Airport side, our two teams along with the Thoubal District Police team rushed to Imphal Airport side to cause arrest of the said accused person. While the police teams were near the Exit Gate of the Imphal Airport looking for the accused person, one Mahindra Bolero (fourwheeler), white in colour, was seen coming from the inside of the airport towards us i.e., the gate of the Imphal Airport. On being suspicious that the Bolero vehicle, the police stopped the Bolero vehicle at around 02.40 p.m. for checking and verification. On checking the Bolero vehicle, five individuals including two minors (a girl and a boy) were found inside the vehicle and one of the occupants was found to be the accused person, namely, Moirangthem Totomshana @ Nongshaba. When the police tried to cause arrest of the accused person with required procedures as per law, the accused person did not co-operate with the police and he objected to such procedures and the accused told to come at police station by himself on their vehicle, Bolero along with other occupants of the Bolero vehicle. It was assumed that as the accused was willing to come at police station, necessary procedures could be completed there and the other occupants of the Bolero vehicle could also be allowed to leave the police station after completion of the procedures for arrest of the accused person. The police allowed the accused to come along with other occupants of the Bolero vehicle, in their said vehicle escorted by police team in

One vehicle (four-wheeler), Tata Harrier, was also seen coming on the rear side of the said vehicles. On the way, the aforesaid vehicles stopped at Keishampat Junction at around 02.55 p.m. due to red light signal of the traffic light. Unexpectedly, the accused jumped out of the Bolero vehicle and he started to run away or escape from the place. On seeing such acts of the accused person, some police personnel chased him and caught him bodily. The occupants in the Bolero vehicle came out and the occupants of the Tata Harrier also came out and they shouted asking the people there to prevent the arrest of Totomshana @ Nongshaba. Soon, many men and women rushed at the place and a commotion occurred there. In the meantime, the accused person assaulted the police (who were near him) and ran away. The aforesaid men and women there numbering about 100 including the occupants of the said Tata Harrier vehicle, obstructed the police to chase the accused person. The accused person escaped from the scene and the police teams could not find him. The other occupants of the Bolero vehicle were taken by the women there.

Hence this report to take necessary action please.
