

I have the honour to report that today i.e. 27/06/2024 at around 06.00 pm, my Royal Enfield, Meteor 350, Fireball Matt Green in colour, bearing Regd. No. MN01AN-8619, having Engine No. J3A5FAR2031374 and Chassis No. ME3J3A5FAR2009418 which was registered in the name of my father namely Urikhinbam Dhananjoy Singh has been found stolen away by some unknown person(s) while kept parking under lock and key inside the Khuman Lampak Sport Complex near Hockey Stadium, P.O/P.S-Imphal, Imphal West District, Manipur and could not trace out till date.
