Sir,

With due regards, I beg to state that today on 29/05/2024 at about 4.30 a.m received a reliable information that some unknown armed miscreants have stored and hidden some arms, ammunitions and explosives in the jungle of Gwarok Ching for using offensive act against State Security Forces and CAPF.

On receipt of the information, Special Operation Group (SOG) Thoubal District Police along with 5/9 Gorkha Rifle and 4 AR, COB Lilong led by Inspt. K. Nitarnanjan Singh, OC/CDO-TBL under the command of Shri. H. Devendra Singh, Addl. SP(Ops)/TBL and under the overall supervision of Shri Rakesh Balwal, Sr. SP/TBL have rushed to the spot immediately and launched a massive operation at 5:00 am by using metal detectors. On searching and found the undernoted articles i.e. (1) 1 (one) no. of SMG Carbine bearing registration number 15227589 with magazine, (2) 1(one) no. of 9mm pistol (Country Made) bearing registration no. A7401 with magazine, (3) 1(one) no. of DBBL, bearing registration no. IN. 12521-D/8 (4) 6(six) no. of 36 HE Hand Grenade(can be used as explosives), (5) 4(four) nos. of Tube Launcher, (6) 2(two) nos. of SLR magazine, (7) 10(ten) nos. of 9mm live rounds, (8) 8(eight) nos. of 5.56 mm live rounds, (9) 40(forty) nos. of 7.62mm live rounds, (10) 4(four) nos. of 12 bore cartridge, (11) 2(two) nos. of Walkie Talkie with charger, (12) 1(one) no. of Tear smoke shell(soft nose), (13) 1 (one) no. of Stun Shell (Anti-Riot) from the spot at 6:30 am. The massive searched Operation was conducted from 5:00 am to 6:50 am on the same day.

So it is therefore, handed over the seized articles to you for your kind consideration and further necessary action.
