Subject: - Report.

Sir,

I have the honor to report that today i.e. 17/06/2024 @ 05:00 pm, while conducting random frisking and checking by joint operation team of Special Operation Team, Mao-PS and B-Coy of 16-AR, Mao near Martyr's Park, Mao about 2 kms south from the PS, one **Bolero (white in colour) bearing Regd. No. AS01AV-3793** was seen coming from Senapati side towards Nagaland. The said vehicle was stopped for frisking and checking. On enquiry, the driver of the vehicle identified as himself Th John (32) yrs S/o R Thezii of Laii Village, Senapati District, Manipur at present staying at TNK, Senapati rented apartment he stated that he is coming from Senapati and heading to Nagaland for some work. On checking the vehicle, suspected brown sugar was found concealed on the back seat of driver in cartoon box. As such DC/SPT has been intimated and a request was made to depute one Magistrate. Accordingly ADM/MAO Shri. Ningreingam Leisan (45) yrs (Executive Magistrate), Song Song was deputed for doing the necessary procedures.

On arrival of the Executive Magistrate and in his presence and in the presence of the driver namely Th John (32) yrs S/o R Thezii of Laii Village, Senapati District, Manipur the vehicle was thoroughly checked. On checking 22 (twenty-two) soap cases were found concealed on the back seat of driver in cartoon box.

The 22(twenty-two) soap cases were weighed by using weighing machine in presence of the Executive Magistrate and witnesses and it was found to be 260 grms including small 22 transparent plastic packet (without the weight of 22 soap cases cover). The approximate value is Rs. 2,60,000/- (Two lakh sixty thousand only). The 22 (twenty-two) soap cases of suspected brown sugar was seized in the presence of Executive Magistrate, Song Song and witnesses by preparing a formal seizure memo. The detained person was formerly arrested at 05:25 pm by observing formalities.

PARTICULARS OF THE SEIZED ITEMS:

1. 22 (twenty-two) soap cases suspected to contain brown sugar, weighing 260 grms including small 22 transparent plastic packet (without the weight of 22 soap cases cover).
2. One **Mahindra Bolero (white in colour) bearing Regd. No. AS01AV-3793** along with key.
3. One mobile phone model name Redmi 5G with IMEI-1 863199062934266 and IMEI-2 863199062934274 and one Jio sim bearing No. 9366154587.
4. One Aadhar card namely Th John (32) yrs S/o R Thezii of Laii Village, Senapati District, Manipur bearing No. **236192163392**.

Therefore, the arrested individual and the seized items were handed over to you for taking further necessary legal action please.
