Sir,

I would like to draw your kind immediate attention with respect to a whatsapp message in Thadou-Kuki dialect that has been widely circulated today i.e. 14/07/2024 at around 6:30 am (a copy of the message has been attached for your perusal). In this regard, it is submitted that Hon'ble MLA Haokholet Kipgen, 51 Saitu AC has been facing threats to damage of property and harm in social media platforms; Whatsapp groups. The message was intentionally circulated to instigate the public; however, it was from an unknown source. The contents of viral news alleged that the two elected MLAs namely (1) Pu Haokholet Kipgen, Hon'ble MLA, 51- Saitu A/C (2) Pu Ngusanglur Sanate, Hon'ble MLA 55- Tipuimakh A/C and (3) Joseph Hmar, President, Hmar Inpui as a traitors for the Kuki-Zo community which can provoke breach of peace. The viral news alleged the (2) two MLAs with 1 (one) CSO leader were holding a peace talk meeting with Shri N. Biren Singh, the Chief Minister of Manipur on 22<sup>nd</sup> June, 2024 in Guwahati. Further, alleging that both the 2 (two) MLAs were in good terms with the Chief Minister of Manipur for their own political gains; seeking for holding cabinet posts in the state assembly of Manipur and they held a peace talk with the Chief Minister of Manipur on the past 22<sup>nd</sup> June, 2024. This viral news was being circulated to different local whatsapp group such as KUKI THUSOH Cfcp MD, EIMI/ENGLISH THUSOH LAHKHOM, SIMTONGBUNG, L. TANGNUAM VANGKHUA, SADAR HILLS, KUKI TODAY, GANGIMNEI THUSOH, LOMLHANG, JINGVALPA NEWS, KANAM JEM & NEWS THINGLHANG POST (1).

It is therefore, requested to register a FIR in this matter and at the same time initiate a thorough inquiry and take up appropriate measure so that no untoward incident happen in the future.
