With due respect I the undersigned have the honour to state the following few lines for your kind information and necessary action.

I have left my pucca house which is under construction at Hillside Colony, Langol, Imphal-West District, Manipur bearing Patta no. 1111/2870 (A). Construction work till the foundation level for three rooms and a septic tank have been completed as on the 3<sup>rd</sup> May, 2023. As I was planning for a two story building I have bought all the required materials like iron bars, sands, stone chips, bamboo, plywood, cement etc, for it upto the completion of first slab.

However, it has come to my knowledge that all the construction materials in the Construction site and tools kept inside the store but have been stolen or looted by unknown miscreants suspected to be Meitei Community probably during the month of June, 2023.

The value of all our properties stolen or looted and destroyed is estimated to be around Rs. 21,95,000/- (Rupees twenty one lakh and ninety five thousand ) only.

I, therefore request you to kindly take up necessary action as per the law.
