I have the honour to state that the ethnic violence that erupted between Meiteis and Kukis on 3<sup>rd</sup> May 2023 has compelled us to flee our homes. On January 18, 2023 I bought an Ingkhol (homestead land) under Patta No. 2278/3424(new), Central Tehsil, covered by C.S. Dag no. 626/638 measuring an area of 0.0297 hectare at National Games Village, Zone-III, Opposite Quarter No. A/85, Imphal West from Mr. Loitongbam Hemchandra Singh s/o (L) Loitongbam Shamjai Singh of Tera Tongbram Leikai. And by the month of August, 2023 I came to learn that the previous owner had illegally occupied the Ingkhol again.

Therefore, I would request you to kindly admit the FIR as per rule. For your prompt action and take legal action against the culprit at the earliest by registering an FIR for which I shall remain grateful to you.

I could not report in time due to prevailing law and order situation within the state.
