With due respect, I would like to state the following for your kind information and necessary action :-

That, due to the on-going conflict, I was compelled to leave my rented house (under homestead land, Patta 175(Old); 98/824(New), Dag No. 1057/1586) at Hebron Veng, Phaipijaang Village, Langol, Imphal West unconditionally on the 4<sup>th</sup> of May, 2023.

Unfortunately, it is also learnt from a reliable sources that all my household properties (listed as under) were ransacked, plundered and looted by unknown miscreants believed to be volunteers of Arambai Tenggol and Meitei Leepun in between 2<sup>nd</sup> – 15<sup>th</sup> of August, 2023.

In this regard, I would like to request your good office to take up necessary action so that I can be compensated, the culprits be caught and stringent exemplary punishment be meted upon them.
