I have the honour to state that, on 04-05-2023 at around 3:10 pm some unknown miscreants suspected to be a members of Meitei Youth Organisations, Meetei Leepun, Kangleipak Kanba Lup (KK1). Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 1000-2000 persons carrying sophisticated weapon like AK Rifles, SLR, INSAS and .303 Riffes, forcefully attacked and entered our locality, Khongsai Veng, Laipham Khunou, Imphal East Dist. Manipur - 795010 about 42 Km south from Saikul-PS in which the unknown miscreants vandalised and destroyed my house and looted all the valuable and moveable household items. They also burnt my house to the ground alongwith all the remaining household items.

The approximate value of the loss properties including the land valuation is calculate d about Rs. 55,000,00/- (fifty five lakhs).

Due to lack of legal knowledge i could not report to the concern authority in time.

It is, therefore, requested you to kindly registered a regular case and take necessary legal action against the culprits according to law.
