Subject: Report on lost of movable and immovable properties.

Sir,

With due respect and humble submission, I beg to state that on 05-04-2023 at around 10:00 PM some unknown miscreants armed youth suspected to be Meitei Youth organization Arambai Tenggol, Meeitei leepun and Kangleipak Kanba Lup (KKL) numbering about 1000 member carrying sophisticated weapons like AK Rifles, SLR forcefully entered my colony Langol Phaipijang, PO - Lamphel, PS - Lamphel, Imphal West district, Manipur. After looting all the properties, the house was also dismantled.

The details of properties lost are as follows:

Residential house, Toilet, Bed (3), Almirah (2), Bed box, Fridge, Cylinder (6), Kitchen items, (10), Blanket (10), Traditional shawl (30), Arm bench (4), Chair (20), Washing machine (1), Solar plate, battery, Drawer (2), Smart TV, Fridge, Sofa set (4), Syntex (2-500L, 2-1000L), Table (2), Dining table set, Stool (4), Flower stand (2), TV stand, Jumbo Box (3), dress Rag (2), Mattress (3), Dresses, Bathroom, 1. Gas box kitchen almerah 2. Generator Honda 1. Water pump 1. Pot 12. Sintex 1000.ltr 1.500 ltr 5. Music system with speaker 2nd hand cloth 2 belt.inverter with battery-1.

The total worth of the properties was estimated to about Rs. 55,00,000 (Fifty five lakhs)

I request you to kindly register the case and take necessary action according to law.
