With due respect, I have the honor to report that on 13th April 2024 at @ 04.20 PM I was returning home by my TOYOTA Fortuner, White in colour, bearing Regn. No. MN05A-5350 having Chassis No. and Engine No. not known which was registered in the name of Gailoungam S/o Adi Pamei of Noney. I was proceeding from Imphal towards Noney while reaching at Naoremthong Road, Tera Bazar along NH-37. Suddenly, some unknown armed miscreants suspected to be members of Arambai Tenggol (as claimed by themselves) numbering about 8 individuals who came in Mahindra Bolero bearing Regn No. not known and Alto car bearing Regn No. WB824C7225 (both black in colour) all are black uniform with masked who were forcibly snatched my TOYOTA Fortuner, White in colour without giving any information. They also snatched away my Mobile handset One Plus 10 Pro having IMEI No. 868368054066172 & 868368054066164 fitted with one airtel sim card bearing No. 7627978503 as well as cash amount of Rs 3,500/ (three thousand five hundred) only in the wallet along with 13 Lakhs in cash wrapped in plastic black in colour which is kept inside the said robbed vehicle.

You are therefore requested to take up necessary legal action and help recovered the above-mentioned Fortuner car and the cash at the earliest.
