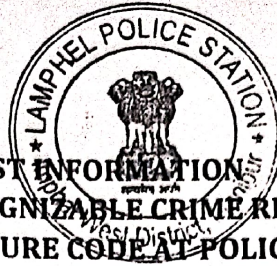

Sir,

With regard to the subject cited above I have the honour to state the following few lines for your kind consideration and necessary action thereof.

That I am bonafide citizen of India and an owner of private resident at 91-Meitei Langol bearing Patta No. 11/2912 CS Dag No. 111/2653 near St. Peter School, National Games Village. PO/PS-Lamphel, Imphal West District, Manipur and had constructed one storey Pucca building with the finance of Housing loan from Punjab National Bank, Lamphelpat RIMS Branch and Singjamei Branch. However, we were compelled to leave the resident after the ethnic violence that broke out on the fateful day of 3rd May, 2023 and took shelter at a safer place in other district. During our absence it has come to our knowledge that on 15/2/2024, our building has been damaged/structural destruction has taken place and all furniture and fixtures inside the building are all looted by unknown miscreants however the exact date and time is not ascertained. For which I am compelled to lodge the FIR report for further investigation of the tantamount destruction to my property.

Further, I would like to state that I am a permanent resident of K. Thiamdawi village, Saikul Sub-Division, Kangpokpi District, Manipur for which I am enclosing my Aadhar Card and Voter Id Card.

Therefore, you are requested to lodge the report for further investigation at the earliest.
