**Subject: - Report on vandalism. Looting and burning of properties.**

Sir,

I am to bring to your notice on the 4<sup>th</sup> May, 2023 between 3:00 P.M. my residence located at National Game Village II Zone, Imphal was attacked by a Group of Meiteis/Meitei's goon numbering 500 to 1000 men.

These criminals broke open my gate and looted every valuable property from my rented house and premises worth Rupees 21,10,000/- (approx..) and they burnt down all the remaining things.

Fortunately, me and my family managed to escaped from these criminals who even tried to kill or burn us alive.

The delay in filling this report is due to the fact that as IDP and we are out of station due to the present violence perpetrated by the said Meitei outlaws.

Therefore, with utmost respect I request you to take strong actions against the perpetrators by registering as FIR under relevant sections of the Indian penal Codes.
