Sub : Report on properties looted and damaged my house at Pushikhul National Games
Village, Imphal from 4th May, 2023 at around 11:AM

Sir,

With due respect, I would like to report that, a cognizable offence carried out against me and my family on 4th May, 2023 at around 11:AM wherein, an angry mob of Meitei Community conspired and instigated by Meitei Leepum and Arambai Tenggol of valley based CSOs attacked, looted and damaged to my private house at National Games Village, Imphal and started vandalizing and ransacking it, rendering me in a state of homeless. Fearing to lose our lives and being in a state of vulnerability. I, along with my wife and daughter had fled and are now taking refuge and shelter at Relief Camp Chingkonpang, Churachandpur.

That the asses/properties and damages were approximate estimated to Rs 10,94,200/-

Further, I regret to inform you that, the delay in filing of this FIR was due to displacement and staying at Relief Camp at Chingkonpang, Churachandpur.

I, therefore, request you kindly to intervention to register FRI against the perpetrations for their heinous acts carried out against me and my family.
