Subject: - Report on crimes of vandalism & looting of properties/Discrimination of Schedule Tribes.

Sir,

With due respect I beg to state that, I am a Schedule Tribe belonging to the Hmar Tribe which is a recognized tribe under the Constitution of India, by virtue of which I am being entitled to the protection under SC/ST (Prevention of Atrocities) Act, 1989.

And with reference to the subject quoted above, I am to bring to your notice that on the 15<sup>th</sup> June, 2023 at around 9 a.m. my Government Quarter (i.e 16/III/B/NC) at Lamphelpat, under P.O. Lamphel, Imphal-West District was looted and then occupied without any order issued from the State Government by a group of Meetei/Meities. These criminals broke open the main gate, destroyed the locks of the main door looted every valuable property from the premises worth ₹ 12,19,500/- (Twelve Lakh Nineteen Thousand-Five Hundred) approx.. And then, occupied the said Government Quarter.

Therefore, with utmost Respect I request you take strong actions against the perpetrators by **registering ZERO FIR** under the relevant sections of the Indian Penal Code.

Cause of delay in reporting is due to my displacement since 4<sup>th</sup> May, 2023.
